

RESOLUTION 18-23
EDUCATION PROTECTION ACCOUNT

WHEREAS, the Provisions of Article XII, § 36, added November 7, 2012, create in the state General Fund an Education Protection Account to receive and disburse the revenues derived from the incremental increase in taxes imposed by Article XIII, 36(f), and

WHEREAS, all monies in the Education Protection Account are continuously appropriated for the support of school districts, county offices of education, charter schools and community college districts, and

WHEREAS, it is the intent of the legislature that all community college districts, county offices of education, school districts, and charter schools shall have the authority to determine how the monies received from the Education Protection Account are spent within the agency, and

WHEREAS, in the spirit of maintaining transparency, the Board of Trustees is required to make the spending determinations with respect to monies received from the Education Protection Account in an open session of a public meeting of the governing board and,

FURTHER, all monies received from the Education Protection Account shall not be used for any other administrative costs except for audit expenses pursuant to the additional audit requirements imposed by Article XIII §36 of the California Constitution.

NOW, THEREFORE, BE IT RESOLVED, that the Berryessa Union School District Board of Trustees determines that monies received from the Education Protection Account shall be spent on teacher salaries as specified on the attachment. This action satisfies the requirements imposed by Article XIII § 36 of the California Constitution.
