September 08, 2020

Education Code 42100 requires the Governing Board of each school district to approve an annual statement of all revenues and expenditures of the district for the preceding fiscal year. This statement must be reported to the County Superintendent by September 15th of each year for verification.

The Year-End Closing process is complete for the Fiscal Year 2019-20. Submitted for Board approval are the financial statements and related SACS forms for 2019-20 Unaudited Actuals.

A. General Fund:

The below items do not include the STRS on-behalf. STRS on-behalf revenue and expense net to zero and may distort the actual difference in revenue and expenses. The revenue and expense amounts for the Estimated Actuals and Unaudited Actuals are \$2,833,162 and \$4,427,862 respectively.

a. Revenue

i. Unrestricted Revenue

1. Local Control Funding changed by \$158k
2. Transfer from Fund 20 is no longer needed and therefore revenue decreased by \$716k
3. Contributions to restricted funds decreased by \$1,027k
4. Total net effect is an increase of \$538k

ii. Restricted Revenue

1. Maintenance
 - a. Contribution decreased by \$145k related to a decrease in expenses
2. Federal Revenue
 - a. Federal Revenue is recognized when actual expense is recognized. Due to the shortened school year, the district incurred less federal expenditures and therefore the district adjusted the revenue as such
 - b. The total decrease of Federal revenue is \$394k
3. Special Education
 - a. Total expenditures were less than expected and therefore there is a decrease in the General Fund Contribution
 - b. State Special Education funds increased by \$254k. This is a refund from the SELPA based on the SELPA's actual expenses
 - c. Total net effect to revenue was a decrease of \$588k

iii. Total Net Effect to Revenue is a decrease of \$589k

b. Expenses

i. Unrestricted Expense

1. Certificated Salaries
 - a. Decreased by \$60k due to some remaining vacancies not being filled
2. Classified Salaries
 - a. Increased by \$21k due to extra hours
3. Benefits
 - a. Decreased by \$177k because of a slight difference in STRS and Medical insurance
4. Supplies
 - a. Decreased by \$276k. This amount was moved to bond expenditures
5. Services
 - a. Decreased by \$183k due to a decrease on utility cost
6. Total expense decrease of \$738k

ii. Restricted Expense

1. Maintenance
 - a. Decreased of \$152k due to decrease in all expense categories
2. Federal Revenue
 - a. Increased by \$284k. This is caused by the addition of Coronavirus Relief Funds. CDE has approved expense in the 2019-20 fiscal year, however, we will not receive the revenue until 20-21. The district moved some food service costs incurred during the start of the pandemic.
3. Special Education
 - a. Decrease of 624k. The decrease is mostly related to vacancies not being filled and a contract services not being used toward the end of the year.
4. Total Net Effect to Expenses is a decrease of \$642k

Part II - Adjustments for Employment Separation Costs

When an employee separates from service, the local educational agency (LEA) may incur costs associated with the separation in addition to the employee's regular salary and benefits for the final pay period. These additional costs can be categorized as "normal" or "abnormal or mass" separation costs.

Normal separation costs include items such as pay for accumulated unused leave or routine severance pay authorized by governing board policy. Normal separation costs are not allowable as direct costs to federal programs, but are allowable as indirect costs. State programs may have similar restrictions. Where federal or state program guidelines required that the LEA charge an employee's normal separation costs to an unrestricted resource rather than to the restricted program in which the employee worked, the LEA may identify and enter these costs on Line A for inclusion in the indirect cost pool.

Abnormal or mass separation costs are those costs resulting from actions taken by an LEA to influence employees to terminate their employment earlier than they normally would have. Abnormal or mass separation costs include retirement incentives such as a Golden Handshake or severance packages negotiated to effect termination. Abnormal or mass separation costs may not be charged to federal programs as either direct costs or indirect costs. Where an LEA paid abnormal or mass separation costs on behalf of positions in general administrative functions included in the indirect cost pool, the LEA must identify and enter these costs on Line B for exclusion from the pool.
