#### HIGH QUALITY COMPREHENSIVE SEXUALITY EDUCATION...

- Kindergarten through 12th grade.
- Is age-appropriate, medically-accurate
- Includes topics related to sexuality: human development, relationships, personal skills, sexual behaviors including abstinence, sexual health, and society and culture.
- Provides students with opportunities for learning information, exploring their attitudes and values, and developing skills for communication and responsible decision making





#### WHY DOES THE RESEARCH TEACH US ABOUT COMPREHENSIVE SEXUALITY EDUCATION?



## CSE HAS BEEN SHOWN TO:

- Reduce the frequency of sexual activity
- Reduce number of sexual partners
- Reduce bullying
- Delay sexual initiation
- Increase contraceptive use and reduce unintended pregnancies
- Increase condom use and lower incidence of STDs and HIV





## CSE HAS BEEN LINKED TO:

- Preventing child abuse
- Promoting social emotional learning
- Advancing gender equity
- Promoting healthy relationships, reducing risks of sexual assault and intimate partner violence
- Increasing health and well-being and academic success of LGBT youth

#### EDUCATION IS NOT ENCOURAGEMENT

4 out of 5 of teens believe it would be much easier for teens to **delay sexual activity** and **avoid teen pregnancy** if they were able to have **more open**, **honest conversation with their parents** about these topics.

# SO WE KNOW IT WORKS... BUT HOW DO WE KNOW WHAT TO TEACH WHEN... AND TO WHOM?

- National Sexuality Education Standards
- CA Health Education Standards

 CA Healthy Youth Act, amended the existing Ed Code (51930-51939) through the CA legislative process in Fall 2015, went into effect in January 2016

 Coalition of supporters include CA School Board Association, CA Teachers Association, CA PTA





# WHY WAS THERE A NEED TO AMEND THE ED CODE IN 2016?



- Technology- increased access to information
  - Sex education in many schools still did not comply with CA Ed Code
    - Missing required content
    - Inaccurate/biased information
    - Outdated materials
  - System continued to marginalize segments of the student population

#### CA HEALTHY YOUTH ACT (CHYA): WHAT'S DIFFERENT AS OF JANUARY 1, 2016?

- CSE and HIV Prevention Education must be provided at least once in:
  - junior high/middle school
  - high school
  - May be provided in age-appropriate way before grade 7. EDUCATION CODE 51934(a)
  - Strengthens and clarifies required content
  - More inclusive tone, prohibits discrimination
  - Parental Notification



# REQUIREMENTS

ALL GRADES, INCLUDING

ELEMENTARY

#### Knowledge and skills based.

EDUCATION CODE 51930(b), 51933(g), (h)

#### Not promoting of any religious doctrine.

EDUCATION CODE 51933(i)

#### Accessible to:

- English learners, and
- Students with disabilities.

EDUCATION CODE 51933(d)(2), (3)



# REQUIREMENTS

ALL GRADES, INCLUDING ELEMENTARY

- Do not reflect or promote bias against any person on the basis of:
  - ✓ Disability
  - ✓ Gender
  - ✓ Gender identity
  - Gender expression
  - Nationality, race, or ethnicity
  - Religion
  - Sexual orientation

EDUCATION CODE 51933(d)(4); see also EDUCATION CODE 220

- Culturally inclusive and appropriate for students of all:
  - Races
  - ✓ Genders
  - Sexual orientations; and
  - Ethnic and cultural backgrounds

EDUCATION CODE 51933(d)(1)



## REQUIREMENTS

ALL GRADES, INCLUDING ELEMENTARY

- Must affirmatively recognize that people have different sexual orientations and include same-sex relationships in examples EDUCATION CODE 51933(d)(5)
- Include instruction on:
  - ≻Gender
  - ➤Gender expression
  - ≻Gender identity
  - The harm of negative gender stereotypes



EDUCATION CODE 51933(b)(6)





## INCLUSIVE CSE

# **REQUIRED CONTENT TO BE INCLUDED**

- Encourage students to communicate with their parents/guardians and other trusted adults about human sexuality, and provide skills for doing so;
- Provide knowledge and skills for forming healthy relationships that are free from violence; and
- Provide knowledge and skills for making and implementing healthy decisions about sexuality



# REQUIRED CONTENT TO BE INCLUDED

- HIV and STDs: transmission, prevention, treatment, reducing stigma
- Access and rights to health services
- Abstinence and delaying sexual activity
- Effectiveness of all FDA-approved contraceptive methods
- Pregnancy, prenatal care, pregnancy options
- Healthy and unhealthy relationships
- Sexual harassment, sexual assault, human trafficking



### PARENTAL NOTIFICATION & OPT-OUT

EDUCATION CODE 51938

#### At the beginning of the school year...\*

**Notice:** Districts must notify parents of the instruction and provide them with opportunities to view the curriculum and other instructional materials.

**Opt-out:** Districts must also allow parents to remove their student from instruction if they so choose, using a passive consent ("opt-out") process in which parents must request in writing that their student not receive the instruction.

Districts may not require active consent ("opt-in") by requiring that students return a permission slip in order to receive the instruction. This applies to all grades, including elementary.

\* Or at time of enrollment, for students enrolling late

#### **INSTRUCTORS, OUTSIDE CONSULTANTS, & GUEST SPEAKERS**

#### ALL INSTRUCTORS

EDUCATION CODE 51931(e), 51934(a)

**Knowledge:** Most recent medically accurate research on human sexuality, healthy relationships, pregnancy, and HIV and other sexually transmitted infections.

OUTSIDE CONSULTANTS & GUEST SPEAKERS

EDUCATION CODE 51936

**Expertise:** Comprehensive sexual health education.

**Knowledge:** Most recent medically accurate research on the relevant topic or topics covered in their instruction.



# TEACHER TRAINING:

- District shall:
  - Provide HIV training
  - Cooperate and collaborate with teachers in developing the training
  - Conduct periodic training on new developments in HIV/ CSE

# THE BUSD PLAN: SPRING 2018

- BUSD 7<sup>th</sup> graders will be receiving Sexuality Education in their Science classes.
- BUSD will use a curriculum called <u>Positive Prevention Plus</u>, which is an updated version of a curriculum that BUSD has used in previous years. Positive Prevention Plus has been reviewed for compliance with the CA Healthy Youth Act.
- 7<sup>th</sup> grade Science teachers will be trained in March and April
- A Task Force of teachers, parents, and administrators will be convened and will work together over the course of the next year. This year the Task Force will informally evaluate the implementation of Positive Prevention Plus. Next year the Task Force will assess other programs if needed to ensure the best fit for the district.



# THE CSE TASK FORCE WILL...

- Assist the district and educational staff to develop a program that is age-appropriate, CHYA compliant, and meets the needs of our community
- Serve as liaisons to other teachers and parents in the community to assess and build support for sex ed in Berryessa
- Task Force meets monthly to plan, evaluate this year's pilot, plan for next fall
  - March 14, 3:30 5:00
  - April 18, 3:30 5:00
  - May 16 or May 23, 3:30 5:00

# **GETTING INTO COMPLIANCE**

- <u>Fast Facts about the California Healthy Youth Acts</u> Short fact sheet with basic information about the law, suitable for distribution at community meetings or for sharing with concerned parents or school district personnel.
- Frequently Asked Questions (developed by the CA Sexual Health Education <u>Roundtable)</u> Basic questions about the law, suitable for sharing with parents, teachers, administrators, or advocates.
- <u>Questions & Answers for School Districts</u> and answer document detailing specific requirements of the law, including references to the relevant sections of the Education Code, intended mostly for district administrators.
- <u>Compliance Evaluation Checklist</u> Checklist for evaluating curricula against the requirements of the law.
- <u>Sample Parent/Guardian Notification Letter SEP</u>Sample letter that meets the requirements of the law for parental notification and passive consent for participation in comprehensive sexual health and HIV prevention education, which can be modified with additional details to meet the needs of individual districts.
- <u>Curricular Materials & Resources</u> List of materials and resources that may be useful for district administrators. Note that this document will be updated regularly.
