CONTRACTOR SHALL BE RESPONSIBLE FOR INSTALL OF PG&E COMPLIANT STRUCTURE / UTILITY GRADE POLE TO MAINTAIN PGE SECONDARY OVERHEAD / WEATHERHEAD IN PLACE. Response: Yes. Straw waddles along the perimeter of the construction fencing and DI protection.

5) Please state intention of A-1.2 general note 12. Should we create an allowance to stop work for a specified time?

Response: The intent of this note is to avoid the school's morning drop-off and afternoon pick up traffic for construction deliveries or if there are other extra-curricular activities that could impact deliveries.

6) The tree to the north of the building is being removed. Please confirm OH lines running through tree are to remain.

Response: Yes, the overhead lines, the building L electrical panel and all associated elements that support the panel and power connection shall remain and be protected. Support these elements as noted under question and response #2 above.

7) We do not have a B license but have an A license. Can we bid on this project with an A license?

Response: There are structural components to this project that require the bracing (carpentry) of existing electrical equipment that require a B licensed General Building contractor. You are more than welcome to partner with a B Licensed contractor for the services that fall within license classification.
