#### Parcel Tax Overview

Measure W, the District's first parcel tax was approved for six years, beginning with the 2009-2010 fiscal year. That first year, the District received 569 waivers and collected \$1,710,192.00 from 21648 Parcels. This term ended with fiscal year 2014-2015.

The Berryessa Community voted to extend the Parcel Tax for eight more years beginning with the 2015-2016. For the 2020-2021 year, the District received 900 waivers and collected \$1,773,866.00 from 22,454 Parcels. This term ended on June 30, 2022, submitting 1,012 waivers.

On November 2, 2021, the Berryessa Community voted to extend the Parcel Tax for an additional eight years beginning fiscal year 2022-2023 and will end fiscal year 2029-2030.

The community members who qualify must be 65 years as of July 1<sup>st</sup> of the year they are applying for the waiver, must own the home and the home must be their primary residence. Others who may qualify are disabled community members, who must own the home and the home must be their primary residence.

1. The meeting was called to order at 3:35 p.m. Introductions were made.

- 2. The January 17, 2023 Measure A Minutes were reviewed and approved. Motioned by Lourdes Calande, 2<sup>nd</sup> by Judy Chia.
- 3. At the last meeting a discussion regarding the process for new appointees be changed. The committee recommended potential candidates not be interviewed during the board meeting. The committee feels that it deters future candidates from applying.
- 4. Kevin Franklin informed the committee that they can change the process as recommended and not require the candidate be interviewed at a public board meeting. To have the process changed, the recommendation needs to be approved by the Board.

He also explained that sometimes adjustments will be made, if needed.
  - It was noted that the line item titles have "Measure K", instead of "Measure A". At this time the name can't be changed because it is in the middle of the budget year. However, Josh will try to change the name to "Parcel Tax" at the beginning of the new fiscal year of 2023-2024.
- 6. Josh Quitoriano presented the proposed Budget Timeline and the LCAP Timeline. He explained that LCAP is for Local Control Accountability Plan. The LCAP is goal specific and specific action are attached to the goal. The timelines show the dates when meeting are scheduled, and the process for LCAP and Budget approval.

- 8. The meeting was adjured at 4:01 p.m.


