Measure K Committee Meeting Minutes

- 1. The meeting was called to order at 6:01 p.m. by Ms. Donna Glanville, Committee President.
 - Jan Anderson, La Toya Brown, Kevin Costello, Donna Glanville, Anh Le, Phuong Le, Pete Reyes, Margot Sandoval, and Tyler Shewey were present. A quorum was declared.
- 2. The Measure K Oversight Committee norms were reviewed. At the October 22, 2013 meeting, it was suggested that a clarification to determine what meets a quorum be added to the Measure W guidelines, now Measure K. On that day, a quorum was not declared, no action was taken.
 - A recommendation was brought up again. It was suggested to declare a quorum by a majority vote of current acting membership. On motion by Mr. Kevin Costello, second by Ms. Jan Anderson, the motion was approved.
- 3. Mr. Peter Reyes was nominated by Ms. Anh Le, for the position of Vice-President of the Measure K committee. Mr. Reyes accepted the nomination. On motion by Ms. Anh Le, second by Mr. Kevin Costello, the motion was approved.
- 4. The May 6, 2014 and September 16, 2014 minutes were reviewed. On motion by Mr. Kevin Costello, second by Ms. Jan Anderson, both minutes were approved as presented.
- 5. There are still three vacancies for Measure K Committee, a certificated staff member (CTAB), a parent to represent the Morrill Middle School family and a parent to represent the Piedmont Middle School family. Ms. Margot Sandoval notified the committee that notices have been sent out to Principals requesting to publish an invitation to their parents and staff to apply to be a committee member.

The invitation will be sent to the Berryessa Sun and School sites, in hope that the vacant positions can be filled.

6. The 2013-14 Expenditures and 2014-15 Measure K Revised Budget was reviewed. Ms. Phuong Le explained that the 11K balance from the 2013-14 expenditures is due to the budget being set from the previous year and the District receiving more funds than anticipated. The 11K was carried over to the 2014-15 fiscal year.

Ms. Donna Glanville asked why there is an increase in FTEs for Library Services, from the previous year. Ms. Phuong Le was not sure why the increase, but will bring the information back to the committee at the March 17th meeting.

It was requested a correction be made by changing the fund title from Measure W ADM fee to Measure K ADM fee.
