## Application for Senior Exemption Form for Measure W Parcel Tax 2009-2014 Fiscal Years

Under the provisions of the Measure W Parcel Tax voted on by the residents of the Berryessa Union School District on November 4, 2008, seniors—those individual home owners who will be at least 65 on July 1, 2009, or for each year where the home owner reaches 65 on July 1<sup>st</sup> of that year – are exempt from paying the \$79.00 per year parcel assessment. To receive the aforementioned exemption, this form must be completed and received by the Berryessa Union School District no later than June 30, 2012. Completed applications and supporting documentation must be submitted by June 30<sup>th</sup> prior to the following July 1<sup>st</sup> fiscal year. All applications must be renewed annually to ensure eligibility. Applications may be mailed or brought into the District Office – Business Services Department – at 1376 Piedmont Road, San Jose, CA 95132. For assistance call (408) 923-1860.

All of the following information must be provided to receive the Measure W exemption. To qualify for this exemption you must both own and reside on the property for which the exemption is requested.
